Financial Review Year to 31 December 2009

Background. A Rocha UK (ARUK) is an independent charity affiliated to A Rocha International (ARI), which assists in establishing, supporting and co-ordinating A Rocha national organisations around the world. Whilst ARUK has its own mission within the UK, its supporters give money and time as volunteers not just to these operations but also to assist projects abroad. In addition to the finances included in ARUK's accounts, ARUK handles funds received from donors in the UK as agent for ARI and A Rocha overseas organisations and passes these on to them.

2009 Financial results. There was a loss on general operations of some £20,000. We are in a tough financial climate- not least for charities- and the trustees were satisfied with the results for the year. This is a result of much hard work done by staff and volunteers. A further £28,000 of exceptional costs arose from the need to provide for the uplift on loan repayments made in 2010 based on an increase in value of the property in Avenue Road. These costs, in lieu of interest, are included in the costs of charitable activities and allocated along with other costs between expenditure categories on a basis designed to reflect the use of the resource.

Despite the financial constraints, we have managed to increase the levels of activity in many areas. A Rocha Living Waterways has focused on community involvement. Elsewhere, there has been emphasis on working collaboratively, with local people and groups in Associated Projects, and with other charities- for example in a tour 'Hope for Planet Earth' which reached some 5,500 over the three weeks. Although the number of committed supporters has continued to grow, donations from individuals and churches, at £227,000, were down around 12% from 2009. Grants from charitable trusts, £76,000, were down 30%, which was disappointing, but income from services provided, eg at Minet Country Park and through conservation consultancy, increased by over 50% from £34,000 to £52,000.

As shown in the accompanying table, incoming resources totalled £409,689 compared with £485,963 the previous year. Expenditure, at £457,608, includes the exceptional £28,000 referred to above, but is still marginally less than the £463,222 in 2008. In addition, in 2009, A Rocha UK handled a further £165,374 as agent for other A Rocha organisations.

Balance Sheet. The net assets on the balance sheet were reduced by the year's deficit, but it should be noted that the Avenue Road property continues to be shown at cost. The original purchase was largely funded by supporters' loans falling due for repayment in 2010. We now know that where these loans were not rolled over for a further period of between 5 and 7 years new loans and donations have been received to cover the cash outflow. We are most grateful to all who have provided finance over the years.

Reserves. We measure these in terms of net current assets. Bearing in mind its commitment to the ongoing programme, including the employment of staff, and the irregularity and uncertainty of income, the Charity seeks to hold reserves equivalent to six months expenditure. At 31 December 2009, discounting property loans, we held reserves equivalent to 4.7 months of total expenditure budgeted for 2010, the same number of months as at 31 December 2008.

Forward look. No significant expansion in financial terms is planned for the immediate future. However, there are many opportunities opening up, and we aim to provide increasing


encouragement and support to local groups through Associated Projects. We continue to seek to increase the number of supporters and the charity's income to enable these opportunities to be met. The charity has wonderfully committed staff and volunteers. Details of our activities and developments may be found in the statutory Report and Accounts, on the website and in our magazine. We also have a monthly A Rocha News which is emailed to supporters on request.



The full financial statements, including the auditor's report and the trustees' annual report have been submitted to the Registrar of Companies and the Charity Commission.
